## FOR INTERNATIONAL CERTIFICATE PROGRAMS

#### IMPORTANT INFORMATION FOR STUDENTS APPLYING FOR THE CERTIFICATE PROGRAMS

**Eligibility:** Application to most UCSC Extension certificate programs is open to international students who have the following minimum qualifications:

- 1. Bachelor's Degree or College Diploma
- 2. English Proficiency score: iBT TOEFL 70, IELTS 6.0, or equivalent and accepted qualifications. Note: English Waiver may also apply if you have at least two years of recent study or completed a degree at university or college from an English speaking country.

Successful applicants are issued a letter of admission to UCSC Extension along with a signed I-20 (Certificate of Eligibility) to support an application for a student visa at U.S. Embassies or Consulates or a change of status in the U.S.

**Academic Requirements:** International students must enroll in a minimum 12 units of classes every quarter with passing grades in these classes. Only three units of online classes may be taken each quarter. The minimum 12-unit requirement does not apply in the final quarter of the certificate program.

**Optional Practical Training (OPT):** OPT is available to F-1 students who have been lawfully enrolled on a full-time basis in an approved college, university, conservatory or seminary for at least nine consecutive months and who have completed their program. One year of OPT is allowed after each level of education (for example, a degree or certificate program).

Programs shorter than nine months do not qualify for practical training.

**Application Processing Time:** The completed application form and supporting documents can be emailed to extensioninternational@ucsc.edu. Normal processing time for an application is three to five business days after submission. If any additional information is required, students are notified via email when their application is being processed.
